



Administration Annual Report

Greetings:

The City of Waverly is a nonprofit local government entity providing essential operations and services to a citizen population of almost 10,000. There are approximately 70 full-time and an estimated 100 part-time and seasonal employees working with an annual operating and capital budget of approximately \$25.7 Million. Areas of service include police, fire, ambulance, library, parks, vegetation management, golf course, swimming pool, cemetery, economic development, community development and zoning, finance, legal, administration, and legislative. Other operations include engineering, airport, streets, water and waste water operations, sewer operations, solid waste collection, and recycling and yard waste.

The City of Waverly completed the Cedar River Parkway, South Riverside Park Phase I improvements, Cedar Lane Reconstruction Phase I project, the decision was made to demolition the 3rd Street SE bridge, the Champions Ridge Ball Diamond project was cancelled, and the Cedar River Park Ball Diamond Project Phase I began.

This year we experienced the pandemic of the Novel Coronavirus, a/k/a Covid-19 creating the need to learn how to hold public meetings via online Zoom.



The City of Waverly is under a Mayor/Council form of government. The Iowa League of Cities explain it best. The Mayor presides over Council meetings. This means the Mayor manages the meetings and maintains order. The Mayor cannot vote on items before the Council, but can veto an ordinance or resolution of the Council.

The authority of the City resides in the City Council. The Council votes on and passes motions, resolutions and ordinances. Some of the resolutions and ordinances that are voted on are in regards to expenditures, the budget, contracts, city policies, and zoning changes.

Resolutions are statements of policy, and ordinances are the laws of the City. The votes of each Council member are recorded in the minutes of each meeting.

Administration Department

James W. Bronner, City Administrator; Carla Guyer, City Clerk; Valorie Northrup; Deputy City Clerk and Bill Werger, City Attorney provide support to Council and City operations.

The Administration's responsibility is to effectively direct and manage City government operations in accordance with the policies and directives of the City Council. We are to advise the Council of community and operational needs and assist in development of ordinances, policies and procedures.

The Administration Department provides services and direction for the operation of seven departments. The Department is responsible for policy development, and regulatory compliance management, and assisting with human resources, and budgeting preparation needs.

Our work goes outside of our departmental walls as we are dependent on the efforts from directors in the other departments. Coordination with other boards and commissions is vital to the effective progress of the "whole City."

City Council, Boards and Commissions and Staff accomplished great successes during fiscal year 2019/20. We are equally proud that municipal workers continue to provide first-rate services to all citizens. We challenge ourselves daily to maintain fiscal stability and to continue to look at multi-faceted budgeting philosophies and revenues.

FY 2019-20 OBJECTIVES:

- 1. Focus on strategic planning efforts with Mayor and City Council, Staff and citizens; then, ensure the enactment of priorities and goals established through strategic planning, goal setting, and the annual budget processes
- 2. Enhance the communication and discussion among Mayor, City Council, Staff, and the public through a variety of methods including work sessions, public information pieces, public speaking, and news media
- 3. Work with outside professionals to develop and enhance the human resource operations and programs of the city, with a goal of controlling health care costs and other associated personnel costs
- 4. Analyze changing service demands and recommend organizational changes as needed across the various departments and services
- 5. Monitor challenges and opportunities both inside and outside the organization for their impact on the City of Waverly
- 6. Work to expand employment opportunities and public and private investment in the community, ultimately growing the tax base
