

Greetings:

The City of Waverly is a nonprofit local government entity providing essential operations and services to a citizen population of almost 10,000. There are approximately 70 full-time and an estimated 100 part-time and seasonal employees working with an annual operating and capital budget of approximately \$23.1 Million. Areas of service include police, fire, ambulance, library, parks, vegetation management, golf course, swimming pool, cemetery, economic development, community development and zoning, finance, legal, administration, and legislative. Other operations include engineering, airport, streets, water and waste water operations, sewer operations, solid waste collection, and recycling and yard waste.

The City of Waverly completed the updates to the LOMR/CLOMR ratings, Adams Parkway bridge improvements, Hwy 3/Bremer Avenue improvements, and a sidewalk was added to the Dog Bark Park via donation made by a citizen.

The City also added two full-time positions this year. The first was a Vegetation Management person. This person will report to the Parks Superintendent and will be in charge of vegetation overgrowth and new plantings. The second position was a Human Resources Manager. This person will be under the supervision of the Accounting/Finance Director and will handle personnel issues.

The two most challenging topics this year were whether to have a 3 or 4 lane Bremer Avenue and what the future of the ball diamonds would be.

City Council, Boards and Commissions, and Staff accomplished great successes during fiscal year 2018/19. We are equally proud that municipal workers continue to provide first-rate services to all citizens. We challenge ourselves daily to maintain fiscal stability and to continue to look at multi-faceted budgeting philosophies and revenues.
