I. Staff Comments

• City Attorney Bill Werger obtained permits from Army Corps of Engineers for the Dry Run Creek Improvements Project and P.C.I. has been working this week as much as they can and box culvert work will begin the week of the 27th. City Administrator Phil Jones met with the Iowa D.O.T. and Canadian National regarding the rail road crossing on 20th Street NW. Since both vehicle and train traffic counts need to be increased so it is possible that the rail road crossing be eligible for some State funding. Concert planning continues. The public will see downtown parking lanes closed sporadically over the next few weeks in order to do tuck pointing and exterior repair of the upper story project.

Council was asked that to bring 2 names from each Councilperson to form a committee for non-profits agencies to refer public funding requests to in preparation of the 16-17 budget planning process. The Waverly Area Veterans Post (WAVP) ground breaking is Wednesday, April 22 at noon.

J. City Council Comments

• Timeline for completion of this phase of Cedar River Parkway is estimated to be late in May. The asphalt removed from 2nd Avenue SW has been milled and used for Babcock Woods Trail Extension and the excess has been stock piled at the dog park to use for the parking lot. Dry Run Creek will be mobilizing back in and excavation will begin for the channel and will begin getting area ready for the first box culvert at 5th Avenue next week. The swimming pool project is on schedule. Painting will begin next week. Pool will be open May 30 this year. Guest Council Betty Westmeyer thanked the mayor for contacting the Iowa D.O.T. and commented on the markings of the street.
