The lots within the subdivision were designed to accommodate one family and two family dwelling units. Those dwelling units are no longer permitted in the R-4 zoning district. While some requirements of the R-2 are not met in Omni, R-2 most closely matches how the subdivision was approved by Council. Changing the zoning to R-2 would avoid title questions and allow the subdivision to continue to build out as intended and approved by Council. The requirements of the subdivision, as approved, would continue to apply in the new R-2 zoning. Since the R-4 zoning classification was already established at the time the subdivision was approved, the lots within the subdivision can be grandfathered in.

    Council had some residents contact them that were in favor of a complete ban on fireworks. Some also thought two (2) weeks was a little long. What is proposed for passage is: June 25 through July 8; Sunday through Thursday (noon to 10:00 PM); Friday and Saturday (noon to 11:00 PM); on the 4<sup>th</sup> of July (noon to 11:00 PM); and also, noon on December 31 to 12:30 AM on January 1. Council expressed sympathy to those with emotional impacts, pets that are bothered by the noise, and small children or babies that would be sensitive to the noise. This approved time frame can be re-visited if it doesn't appear to work out this year. There were still concerns of the Council trying to fix a problem that doesn't seem to exist.

- In some cases, including the Cedar River Parkway project, when we are bonding for a project the expenditures are paid from reserve monies until the bonds are sold and dollars come into the City. This allows payment to contractors. The timing for the end of last fiscal year budget and the beginning of the current fiscal year budget causes other amendments such as for the airport land acquisitions. Other contributing factors affecting the budget amendment include: computer, server and technology upgrades; SCADA program, drive cage west clarifier, legal expenses for bonds and labor relations, pool pump, dog park water issue, Kohlmann Park Tree removal, items that came in over the budgeted amount, and other minor changes noted by departments. As part of IMWCA updating classifications, there was also an 80% increase in worker's compensation for the fire department even though there were not any large claims for the firefighters.

- I. Regular Business.
  - 1. Review of the Waverly Utilities 2017 Audit.
    - Waverly Utilities Director of Finance Kasey Lewis reviewed an audit prepared by EideBailly of Dubuque, Iowa. For fiscal year 2017, Waverly Utilities received an unmodified opinion which is the best opinion that you may receive. There were also no material weaknesses or internal control deficiencies. The independent auditor's report outlines the auditor's responsibilities and their opinion. The next section, the management discussion analysis, provides a three (3) year comparison of the financials for Waverly Utilities including discussions on budget vs. actual, fund balances, capital assets and debt activity. Operating revenues for the electric utility were up \$500,000 in 2017 compared to 2016 and expenses were up \$160,000 in 2017 compared to 2016. The year was ended with a reduction of \$3,000 to the net position after the transfer of cash to the City of Waverly. In 2017, there were 31 new customers installed with a total of 192 new customers installed since 2014. Even though total kilowatt usage has decreased since 2014, 2017 compared to 2014 shows a decrease of 7.3 million kilowatt hours. This is being contributed to energy efficiency and more temperate weather. There were two (2) minor Iowa State compliance issues. One was related to the prior board chair being a related party and the other was due to August board minutes not being published in the local newspaper; however, they were published on the web site. Curt Atkins, also of Waverly Utilities, explained that street light usage was up due to the Bremer Avenue reconstruction with repairs and updates to the antique street lights.

This is in order to cross the right of way and the tracks.

The signals are budgeted as part of the overall project costs. Staff informed Council they would communicate this type of system with Wartburg College and see if they would be interested in something like it for the 5<sup>th</sup> Street crossing by the college.

## L. City Council Comments

- Councilmember Birgen recognized that both Wartburg College and Waverly-Shell Rock High School would be holding their graduation ceremonies this weekend (May 27) and congratulated all the graduates.
- Councilmember Drenkow noted that was he very glad to hear the City will have more pedestrian-assist crossing signals along Bremer Avenue. Mr. Drenkow also commented that the paint on the crosswalks needs to be reapplied.
- Councilmember Waldstein reminded folks in the community to visit the downtown businesses especially in this time of Bremer Avenue/Hwy 3 reconstruction.
- Councilmember McKenzie expressed concern for the overgrowth of trees along 1<sup>st</sup> Avenue that seem to cover street signs. Mr. McKenzie also shared that he has received many emails regarding Champions Ridge and thanked those people that have emailed to show their support.
- Staff informed Councilmember Sherer that the work around the railroad track between Casey's and Pizza Hut on Bremer Avenue may be done by the weekend, if not, it will be soon after. Bremer Avenue reconstruction will be completed to the west of the railroad tracks to Casey's as soon as the work for the railroad tracks is finished. When the 300-foot stretch is complete, they will begin reconstruction of Bremer Avenue from 12<sup>th</sup> Street (by the Dirty Dog) east to 6<sup>th</sup> Street (by Family Video/Jimmy John's/Tobacco Outlet).

## M. Mayor's Comments

• Staff informed Mayor Soash that there will be a resolution presented to Council at the June 4<sup>th</sup> meeting as part of settlement for the Artesian land acquisition after the condemnation hearing. There is still one (1) property needing to be purchased for the Airport project. Mr. Soash also recognized that several employees of the City have many years of service with the City and thanked them for their service. The City supports Champions Ridge. He hopes that the community will show their support by helping with the fundraising so this project can happen.
