7. Description

This single-family house is estimated to have been built in 1912 according to Bremer County Assessor records. The house form and style are consistent with similar houses in Waverly built using this form from ca. 1900 to 1920. Property Transfer Records show this property held by F.P. Hagemann and transferred to John C. Pries in November 1913. Construction was completed over the following winter and according to a February 26, 1914 account in the *Bremer County* Independent, the Pries family would move into the house shortly. A year later, the house was transferred to E.A. Schiefelbein. Members of the Pries family were carpenters so it is possible that the house was built on speculation and that the Schiefelbein family were the first permanent occupants despite the newspaper account. A construction completion date of 1914 is more consistent with public records.

This house is an example of a vernacular Hipped Roof, 1½-story house form. The house has a rockfaced concrete block foundation on the main block and the walls are clad in narrow-width vinyl clapboard-style siding. The house has a steeply pitched hipped roof with moderate eaves and gabled wall dormers with prominent returning cornices on all four slopes. A broad, low-pitched hipped roofed porch spans the front façade. The porch features diagonal lattice skirting boards, four full-height, smooth columns across the front, centered entrance steps, and balustrades composed of narrowly spaced square spindles. A second enclosed entrance porch is on the rear façade of the main Fenestration for the house includes a mix of single and paired 1/1 double-hung windows of various sizes. The dormers have single 1/1 units. Feature windows include identical cottage windows to either side of the centered main entrance with single light configurations for both the upper horizontal and lower square sashes. The elaborate entrance door design has a full height window with a geometric pattern of leaded-beveled lights.

The house has a 1-story double-bay, detached frame garage along the north side opening onto the alley. The garage was built in 1998 according to the Assessor records. It has a broad, low-pitched front-gable roof with matching vinyl clapboard-style siding.

Alterations: vinyl siding, undated; porch lattice skirting panels, undated; entrance step handrails, undated; garage addition, 1998.

8. Significance

The John C. and Dorothea Pries House at 314 3rd Ave NW was built in 1914 and is an example of a vernacular Hipped Roof, 1½-story house form. The house qualifies for the National Register of Historic Places as a contributing resource to the historic district under Criteria A and C.

John C. Pries acquired this property in November 1913 and set about construction shortly thereafter. On February 26, 1914, John and his wife, Dorothea or Dora, were about to move into the house according to a *Bremer County Independent* account: "John Pries' new house in the Second ward has been completed and Mr. and Mrs. Pries will move into it this week. When thoroughly settled, Mr. and Mrs. Pries will have a very pleasant residence." In the 1913 city directory, John was listed with no occupation but two other Pries family members, Theodore and Theo, were listed as carpenters. The

1895 Iowa Census lists John and Dora Pries residing on a farm in Maxfield Township. Marriage records show the couple marrying in 1881 at St. Paul's Artesian Lutheran Church.

The Pries family sold this property in May 1914 to E.A. Schiefelbein, a local attorney. He held the property until the mid 1920s. It is not known whether or not he and his wife, Nettie, resided here. In 1925 the house passed to E.H. Epley who is listed as residing here in the 1926 telephone book. Six years later the house was sold to H.L. Pinney.


