7. Description

This house is estimated to have been built in 1934 according to Bremer County Assessor records. This date is consistent with the design and form of the house as well as newspaper accounts dating from June and July 1935 when Carl Homan was the owner. The property was acquired from Waverly Homes, Inc. in June 1935 shortly after the company began building homes in Waverly. Contractor for the house was Fred Flege, Carl's uncle. A more accurate date for the house would be 1935 given this public information.

The Homan House is an example of a Craftsman Style Cottage 2-story house form. The house has a concrete foundation, asbestos shingle siding with wavy, lower edges on the walls, and narrow corner board trim. The house has a moderate-pitched side-gable roof on the main 2-story portion of the house and a steeper pitch on the front-gable wall dormer with a contiguous front-gable entrance bay. The rear slope has a shed roofed dormer. The moderate width eaves on the main house and entrance bay are lined with exposed rafter tails. The entrance bay has an eye-brow shaped entrance hood with wide moldings and supported by fluted brackets.

Fenestration includes a combination of single, paired and grouped double-hung windows of various sizes with three vertical lights in the upper sashes and a single light in the lower sash. A window box once located on a bracketed shelf west of the entrance bay has been removed.

The house retains its original single-bay detached garage at the south end. It has a moderatepitched front gable roof with matching asbestos shingle siding and corner board trim. A wood paneled overhead door is present with a horizontal and glass paneled passage door in the east gabled end. According to Assessor records, the present garage was built at the time the house was constructed.

Alterations: window box removal, undated.

8. Significance

The Carl Homan House at 521 4th St NW is an example of an example of a Craftsman Style Cottage house form. The house was built during the Great Depression as the 2nd Ward continued to experience infill housing in the Harmon and LeValley Addition. The house qualifies for the National Register of Historic Places as an individually significant property under Criterion A and C and as a contributing resource to the historic district under Criterion C.

Carl Homan and his wife occupied this house from its completion in ca. 1935 until the early 1940s. Carl acquired the property from Waverly Homes, Inc. in June 1935 shortly after the company began building homes in Waverly in response to the local housing shortage. A news account re: the formation of Waverly Homes, its incorporators and its purposes is on the following page.

The property was sold to Lena Homan, Carl's mother, a year later but Carl continued to reside here until the early 1940s. According to Carl Homan's daughter, Mary Meyer, "This home was constructed for Carl Homan (1900-1974) in the summer of 1935. Later that same year his sister,

The work of drawing up articles of incorporation was started Tuesday, and as soon as they have been approved by the state, the corporation will get property and start building operations.

Property has been examined in various parts of town, and lots suitable for dwellings will be chosen. It is thought that one-lot areas will be used.

Look Over Plans Houses will be constructed according to several approved plans, probably five-room houses, or possibly four-room. They will cost from \$3,000 to \$4,500 unless they are built to order for sale, in which case higher-priced homes may be had. These houses are primarily for rent—to relieve the overcrowded housing situation which exists now—although the houses will always be for sale.

Three houses at least will be built at first, although the number is likely to be as large as five or six. More homes may be built at a later date.

When the houses are rented, 1 rents will be kept quite low in order to make the new houses as useful to renting population as possible. They will be sold, when patrons wish to buy them, on the modern installment plan of payments like rent. Amanda Homann Gerberding, and her husband William built a home across the street at 521 4th St NW. Fred Flege, their uncle, was the contractor for both houses. In the 1920s and 1930s Carl was the driver for Dr. W.A. Rohlf, a pioneer doctor in Waverly's early history. After the doctor's death in 1939, Carl became the x-ray technician at the Rohlf Memorial Clinic; he was also Waverly's Fire Chief from 1930 to 1960. Carl Homan owned the house until the early 1940s." (Interview with Mary Meyer, Carl's daughter and Waverly Historic Preservation Commission member) Copies of two articles and a photo of the house under construction appear below.

Property transfer records show Lena Homan transferring the house to William and Anna Clausing in February 1942. William died four years later and the property passed to Anna. Her heirs passed the property to Ernest and Eugenia Oberhaur in August 1951. The couple resided here while Ernest worked for Carnation Milk Company located several blocks to the northeast. The property remained in the Oberhaur family until 1995 when Jerry James Rockford, Jr. acquired it.

From the Bremer County Independent of June 5, 1935, page 1:

Homan Will Build on Fourth St. N.W.

Work on excavation for the basement of the house which Carl Homan will build on the Charles Menzel lot on Fourth St. N.W. was started Monday afternoon. The lot is south of the residence occupied by Mr. and Mrs. Adrian Martin and family. The home will be of frame construction, approximately 24x26 feet in size. In design it will be quite similar to the office building at Harlington cemetery. It will contain six rooms and bath. Fred Flege is the contractor.

From the *Bremer County Independent* of July 10, 1935, page 1:

Homan Residence Progresses

Construction work is now going ahead rapidly on the residence being built by Carl Homan on Fourth Street N.W. The house will have a living room, dining room, kitchen and bedroom downstairs, and two bedrooms and a bathroom upstairs. Construction work is in charge of Fred Flege.

Relationship of Homan family members from Mary Meyer, Carl's daughter and Lena's granddaughter, (email from Mary Meyer to Marlys Svendsen, 3/20/2013):

"Lena Homan(n) was my grandmother and lived in my house at 315 2nd St NW from 1922 until she died in 1965. After my grandfather died in 1920, she stayed on the farm in Douglas Township north of Waverly for about a year and a half, and then sold it and moved to town. She is buried in a country church cemetery in Douglas Township.

She had three living children in 1922: a daughter Hilda Fischer, also a widow, who lived with her here; a second daughter Amanda who married William Gerberding; and my father, Carl Homan.

Lena, Hilda and Carl lived together in my house until my father married his first wife, Ila Johnson, in 1923. By that time the Gerberdings were also married and living in Waverly. Children soon followed, two sons for my father and three daughters for his sister Amanda.

What I recall my father telling me (more than 40 years ago) was that Lena gave him \$5000 and also gave that amount to Amanda to build the houses on 4th St [508 and 521 4th St NW]. The idea was that they would pay the money back gradually and she would thus have an income in later years (she was nearly 60 at this time). I didn't realize until recently that her name actually appeared in the two property transactions.

Fred Flege, the contractor for the two houses, was Lena's brother. They were born in Germany and came to this country with their parents and three siblings in 1883. Fred was a carpenter like his father; I don't know if he had a connection to Waverly Homes Inc."


