#### 7. Description

This single-family house is estimated to have been built in 1910 according to Bremer County Assessor records. The house form and style are consistent with houses in Waverly built during the years leading up to World War. A house at this address appears in the 1913 city directory listings as occupied by William Blain. The property was owned, however, by George E. Blain, a concrete block homebuilder (family relationship unknown), between 1901 and 1920. During that period, it was retransferred to George Blain from his mother (or aunt) several trims, the last being January 1911. Together these public records suggest that the house was erected between 1911 and 1913. A construction date of ca. 1911 appears to be more accurate.

This 1½-story concrete block and stucco dwelling is an example of a Craftsman Style Bungalow house form. The house has a rock-faced concrete block foundation built using Blain Cement Co. block with matching block walls on the first and second floors. All mortar for the house was originally a dark red color with some of the tint still visible. The gable wall dormers have a wide band of stucco at their base topped by peaks filled with asphalt shingles, possibly replacing earlier wood shingles. The house is one of several concrete block houses constructed by George E. Blain, an early cement block manufacturer and homebuilder in northwest Waverly. The house has a complex roof plan that includes a moderate-pitched center hipped-roof section with gabled wall dormers of varying sizes and positions on all four facades. On the front façade, the gabled dormer is set back on the roof slope of the second floor forming a recessed balcony. The balcony has a stucco balustrade with curved ends and screen panels. (Note: This balcony design is similar to the balcony of the Schlaberg House at 422 2<sup>nd</sup> Street SE where Blain did the foundation work). On the south and north facades, the large wall dormers have wide stucco band across the bottom of the broad gables, molding separating the stucco from the concrete block below and asphalt shingles in the peaks, and deep returning cornices. On the west, the wall dormer is taller opening into the attic level or rear staircase.

A low-pitched hipped roof porch extends across the full front with the entrance steps at the south end. The porch has a matching concrete block foundation with the balustrade featuring short-height versions of the main block used. Concrete block pedestals with large block are located at the outer corners of the porch and at the entrance steps. Tapered columns rest on the pedestals to support the porch roof. The balance of the porch has a concrete deck, concrete block planter box and pedestals at the corners of the entrance steps. The areas above the balustrade are filled with screen panels.

Fenestration for the house includes widely spaced double-hung windows with Craftsman Style 3/1 configurations (vertical lights in the upper sashes). Several sizes and shapes appear mostly pairs and groups of three on primary and secondary facades. On the front façade, first floor, the main entrance is located opposite the steps. It has sidelights with tall oval lights flanking the front door that also has a large beveled glass window. To the right of the entrance, a large double-hung window features five vertical lights in the upper sash. On the north façade similar windows are in use.

A detached single-bay garage with is located west of the house. It has a moderate-pitched front-gable roof with a single replacement overhead door in the gable end facing the avenue. It is clad in matching stucco finish with asphalt shingles in the gable end. It was constructed in 1910 according to

Assessor records or more likely in 1911. Wood shed-roofed additions are present on the west and south sides for additional storage space. The garage has several doors and 6/6 windows. Alterations: none noted (undated).

#### 8. Significance

The Blain/Niemeyer House at 323 5<sup>th</sup> St NW built in ca. 1911 is an example of a well-preserved Craftsman Style Bungalow house form from the pre-World War I period. It is typical of several other concrete block and stucco houses built in northwest Waverly by block manufacturer and contractor, George E. Blain. The house qualifies for the National Register of Historic Places as a contributing resource to the historic district under Criterion C.

According to property transfer records, Eliza and William Blain, Sr. sold all of Lots 1 and 2 in Block 50 of Harmon and LeValley Addition to George E. Blain on August 30, 1901. In 1903, George sold the south half of these lots and retained the north half. In 1911 a year after William's death, Eliza retransferred the north half to George Blain. In 1915 she also issued a quit claim deed on the north half. It is believed that some lack of clarity in the title caused the 1911 retransfer before George built the house at 323 5<sup>th</sup> St NW. After the house was finished but before it could be sold by George, it was rented by to a member of the extended Blain family – William Blain and his wife Lottie. William worked on the Waterloo, Cedar Falls and Northern RR while residing here.

In 1915, there was need for the issuance of the quit claim deed before George Blain could sell the house at 323 5<sup>th</sup> St NW to a new buyer. That buyer turned out to be Gustav Niemeyer in February 1920. Gustav and his wife Emma held the property until October 1946 when the house was sold to Frank and Sarah Lageschulte.


