7. Description

This single-family house is estimated to have been built in 1898 according to Bremer County Assessor records. The house form and style are consistent with houses in Waverly built before and after World War I making this estimate inaccurate. A house at this address appears in the 1913 city directory listings as occupied by J.H. and Ida Lutz, likely an earlier house on the south half of Lots 1 and 2. In November 1913, the Lutz family sold the property to Frank Lauer and his wife Ellinanda (Alemanda). A construction date of ca. 1914 appears to be more accurate for the house at 423 5th St NW.

This 2-story frame house is an example of a vernacular Gambrel Roof, 2-story house form. The house has a rock-faced concrete block foundation with portions parged. The walls are clad in medium-wide wood clapboard siding on the lower level and wide aluminum side in the gambrel ends. A moderate-pitched gambrel roof with two shed-roofed attic dormers on the east and west slopes extends over the main block and a small 1-story entrance wing with a stoop is at the main entrance. The original main entrance is at the north end of the front façade with the original small porch located here now removed and replaced by a concrete deck. A 1-story addition wrapping the south and rear facades has a flat or slightly pitched shed roof. Fenestration throughout the house includes widely spaced single 1/1 double-hung windows. On the first floor, front and north façades, single large fixed sashes appear to have replaced pairs of earlier 1/1 double-hung windows.

A detached frame 1-story gambrel roof garage is located west of the house and is accessed off 4th Ave NW. It has a gambrel roof with the gambrel end facing the avenue. It is clad in board and batten wood siding with tongue and groove boards in the gambrel end and a replacement overhead door on the north façade. Assessor records date the garage as having been built in 1970.

Alterations: 1-story south and rear addition (pre-1952); front porch removal (post-1952); foundation parging (undated).

8. Significance

The Lauer House at 423 5th St NW was built in ca. 1914 and is an example of vernacular Gambrel Roof, 2-story house form from the pre-World War I period. It is a relatively rare example of this form in the Harmon and LeValley Addition. The house qualifies for the National Register of Historic Places as a contributing resource to the historic district under Criteria A and C and the garage is considered noncontributing.

J.H. and Ida Lutz owned Lots 1 and 2 in the Harmon and LeValley Addition beginning sometime in the late 1890s when they acquired it from William Blaiser who held the two lots as part of a farm on the north edge of town. In 1913 the lots passed to Ida when her husband died; the couple was residing at this address in the 1913 city directory listings, likely an earlier house on the south half of this parcel or on this part of the parcel. In November 1913, the Lutz family sold the north half of the two lots to Frank Lauer and his wife Ellinanda (Alemanda). They are believed to have completed construction the following year. Frank was listed with no occupation in the 1913 directory and given the couple's age, 74 for Frank, they were likely retired at the time.

Frank died in 1920 and the house passed to his wife. She died in 1941 and the house was transferred to their son, J.Q. Lauer. He and his wife Lillian resided here until 1959 when they built the house next door. He worked part of his life as an engineer before he and his wife sold the house and built another next door to the south in 1959. The house at 423 5th St NW was sold in 1958 to Virgil and Lucile Owens.


