7. Description

The Babcock House at 508 2nd Street SW is estimated to have been constructed in 1915 according to the Bremer County Assessor's records. City directory research shows the house was in place when the 1913 directory was published suggesting a construction date of ca. 1912. This date is consistent with the building's form and design.

The house is an example of the Colonial Revival Architectural Style applied to a vernacular Hipped Roof, 2-Story house form popularly known as the American Four-Square. The building has a rock-faced concrete block foundation with narrow-width wood clapboard siding, wide cornice boards, a belt course between levels, and corner board. An unusual detail is the use of flared corners and corner boards on the upper level. The house has a moderate pitched hipped roof with modillions lining the wide eaves and a hipped attic dormer on front slope, also with eaves lined in small modillions. A flat roofed porch spans the front façade with three slender posts (likely replacements) resting on concrete block pedestals. Entrance steps are on the right side opposite the front door. The balustrade has closely spaced 2x2 inch spindles and the rail has a curved shape. The porch has a concrete deck with a smooth-finished concrete block foundation that may be a replacement for frame elements.

Fenestration includes a mix of 1/1 double-hung window units, a replacement single-light sash for a cottage window to the left of the entrance, small square single-light sash in the dormer, and a keystoned oval sash centered on the front, upper level – a classic Colonial Revival element. The entrance surround includes a rectangular transom above the door, which features a full-height beveled glass door, and tall and narrow 1/1 windows on each side. The property has a single-bay frame garage constructed in ca. 1912 that is considered contributing. It has a steep pyramid roof with matching narrow clapboard siding and corner board trim on the walls. Its good integrity is enhanced by retention of the original folding doors that have tongue-and-groove panels and 6-light windows in the top third.

8. Significance

The Babcock House at 508 2nd Street SW derives individual significance under Criterion C as an example of a Colonial Revival Style residence built using the Hipped Roof, 2-Story house form popularly known as the American Four-Square. The building's high level of integrity adds to its significance. The garage is considered a contributing resource. The house is also significant as a contributing resource in the Sturdevant SW Historic District under both Criteria A and C. The historic district qualifies for the National Register of Historic Places as a well-preserved collection of mid and late 19th century and early 20th century architectural styles and vernacular house forms located in Waverly's southwest residential neighborhood. The neighborhood developed as a middle class and working class residential district from the late 1850s through the mid-20th century.

Historical Background for Waverly¹

Waverly was established in 1853 along the Cedar River in Waverly Township located in southeastern Bremer County. It was designated as the county seat for Bremer County the same year that the county was officially organized and was formally incorporated in 1859. Like most lowa towns established before the Civil War, growth during the early 1860s was deferred until after the war came to a close. Waverly's first railroad, the Cedar Falls and Minnesota Railroad was extended to Waverly in 1864. Eventually track was also laid for other branch lines and an electric interurban. By 1917 track for branch lines was absorbed by the Chicago and Great Western Railroad and the Chicago, Rock Island and Pacific Railroad. Track for the electric interurban – the Waterloo, Cedar Falls, and Northern – was laid in 1910 but usage was never as substantial as predicted.

Waverly grew in the manner typical of other lowa county seats in the late 19th and early 20th century. Its commercial center extended along the east-west route of Bremer Avenue on both sides of the Bremer Avenue Bridge that crossed the L-shaped course of the Cedar River as it passed through the center of town. The county courthouse was located outside of the commercial area on a slight prominence at the east end of Bremer Avenue. Residential districts grew up in the four quadrants formed by the intersecting main street and river. The broad, generally flat profile of both the business district and early residential neighborhoods saw the regular occurrence of flooding resulting in the gradual replacement of most first generation frame building stock. German immigrants were among the largest ethnic group to populate Waverly during the 19th century establishing religious institutions with ethnic affiliations such as St. Paul's Lutheran Church in the northwest quadrant, St. Mary's Roman Catholic Church in southeast quadrant, and the German Methodist Church.

Bremer County and its county seat of Waverly prospered during the late 19th and early 20th century becoming a retail and professional services center for Bremer County and sections of adjacent Butler County. The county's standing as the "Dairy Spot of Iowa," gave rise to a number of dairy industries including a manufacturing plant operated by the Carnation Milk Products Company for the production of condensed milk in the 1920s. Population stood at 16,300 people in 1900 before the growth rate slowed before World War I. By 1930 population topped 17,000. Expansion of a Lutheran seminary in Waverly first located in the community in 1879 through the relocation of Wartburg College to the community in 1939 was a cultural and economic stimulus for the community. Waverly continued to add a 1,000 people per decade until 1950 when the post-War boom saw growth accelerate to more than 21,000 by 1960. During the past 50 years population has slowed somewhat topping out at 23,325 in 2000.

Historical Background for the William and Edith Babcock House at 508 2nd Street SW

The William and Edith Babcock House at 508 2nd Street SW is estimated to have been constructed in 1915 according to the Bremer County Assessor's records. However, the 1913 city directory shows the house already in place with William H. Babcock and his wife Edith resided there (508 S. Elm Street). A construction date of ca. 1912 is consistent with the architectural style and vernacular architectural form of the building. Biographical information researched by local historians indicates that William Babcock arrived in Waverly in 1887 at the age of 22 and soon found a job as a bookkeeper. He was eventually elected Bremer County Recorder and occupied this position until 1904 when he took the position of cashier for the Waverly Savings

Bank. William Henry "Wil" Babcock was employed in this position in 1913 according to the 1913 city directory. At the same time, the couple's daughter, Iva, a school teacher, resided at the family home. During his career, Wil also was a member of the Waverly City Council, the school board, and contributed to the establishment of the Bremer County Fair. A brief biography follows:

Babcock, William H.

William H. Babcock, an enterprising and representative citizen of Bremer county, has for the past nine years been identified with financial interests as cashier of the Waverly Savings Bank. His birth occurred in Lysander township, Onondaga county, New York, on the 6th of June, 1865, his parents being William H. and Catherine E. (Martin) Babcock, likewise natives of the Empire state. The father, an agriculturist by occupation, passed away before the birth of our subject, dying from the effects of a wound received in the battle of Groveton, Virginia, while fighting with the Union army. The mother survives and makes her home in New York.

William H. Babcock, the only child of his parents, obtained his early education in the district school of his home vicinity and subsequently continued his studies in an academy at Baldwinsville, New York. In October, 1887, when a young man of twenty-two years, he came to Waverly, Iowa, and on the 3d of January of the following year secured employment as a bookkeeper with Edward Knott, in whose service he remained until the fall of 1895. In the fall of 1896, he was elected county recorder and ably discharged the duties devolving upon him in that connection until January 1, 1901. At the end of his term of office he went to Welsh, Louisiana, and there became identified with financial interests as cashier for Calkins, Spalding & Company, private bankers, with whom he continued for one year. He then returned to Waverly and on the 1st of February, 1904, entered the Waverly Savings Bank as cashier, in which capacity he has remained continuously since, enjoying an enviable and merited reputation as an able, courteous and obliging official of the institution.

On the 5th of November, 1890, Mr. Babcock was united in marriage to Miss Edith P. Dove, who was born near Waverly, Bremer county, her parents being William C. and Lydia M. (Brown) Dove. The father, a native of England, emigrated to the United states with his parents when quite young and in the year 1861 came to Bremer county, Iowa, devoting his attention to general agricultural pursuits until 1897. During the past sixteen years he has lived retired at Waverly. Mr. and Mrs. Babcock have two children. Iva C., who was born on the 31st of October, 1892, and is a graduate of the Waverly high school and also a graduate of the musical department of the Iowa State Teachers' College at Cedar Falls, completing the course with the class of 1913 and is now teaching special music in the public schools of Humboldt, Iowa. William D., whose natal day was March 13, 1904, is attending school.

Mr. Babcock gives his political allegiance to the republican party and, as stated above, served as recorder of Bremer county for four years. He likewise acted as a member of the city council for five years and has also done able service on the school board, making a creditable record as a public official of ability and worth. A public-spirited and loyal citizen, his cooperation has been sought and given in the promotion of measures instituted for the development and growth of the county along material lines. He is a member of the board of directors and one of the organizers of the Bremer County Fair and has served on the board of the Waverly Industrial Association since its inception. Fraternally he is identified with the Knights of Pythias. He is highly respected and esteemed by all who know him and enjoys the friendship of many who honor him for the high qualities of his mind and character and his public-spirited, truly American citizenship. 
