7. Description

The Burbank-Richards House at 209 4th St SW is estimated to have been constructed in 1898 according to the Bremer County Assessor's records. This date is consistent with the building's form and design. The house footprint is not seen on the 1894 Sanborn Map of Waverly indicating that it was constructed after that date. Property transfer records indicate the property was held by the Jerome and Jerusha Burbank family until April 20, 1898 when it passed to Minnie M. Burbank. Then on 5/10/1909 the property passed to the Richards family. Therefore, these public records and the design of the building confirm a date of ca. 1898.

The Burbank-Richards House is an example of a vernacular Gable-Front-and-Wing 2-story house form. The building has a stone block foundation and narrow clapboard-style vinyl siding on the walls. The house has a moderate pitched intersecting-gable roof with gabled wall dormers on the north and south slopes of the front-gable wing. The right-hand ell is filled by a small mansard-roofed entrance porch that is now enclosed. A low shed roof has been added to the porch for better drainage. The porch was enclosed in ca. 1910 when the use of similar concrete block found here was documented for other Waverly homes.

Fenestration includes tall and narrow 1/1 double-hung window units of several sizes throughout the house widely spaced or in pairs. A larger opening containing a pair of narrow 1/1 units or single 4-light window is on the first floor, front façade. A similar window group faces south from what was likely the dining room.

The house has a detached garage completed in ca. 1918 according to Assessor records. It measures 20 x 18 feet, is clad in wide beveled wood siding with wide corner board trim, as a low-pitched clipped front-gabled roof, and is located at the rear of the house. The garage appears to have originally had a single opening with by-pass doors in a wider opening. The doors, however, have been retained and now are used to close two smaller-width openings. Because of its age, original materials, and a substantial portion of its original design, it is considered a contributing resource.

8. Significance

The Burbank-Richards House at 209 4th St SW derives significance as a contributing resource in the Sturdevant SW Historic District under both Criteria A and C. The historic district qualifies for the National Register of Historic Places as a well-preserved collection of mid and late 19th century and early 20th century architectural styles and vernacular house forms located in Waverly's southwest residential neighborhood. The neighborhood developed as a middle class and working class residential district from the late 1850s through the mid-20th century. The garage is also contributing.

Historical Background for Waverly¹

Waverly was established in 1853 along the Cedar River in Waverly Township located in southeastern Bremer County. It was designated as the county seat for Bremer County the same year that the county was officially organized and was formally incorporated in 1859. Like most lowa towns established before the Civil War, growth during the early 1860s was deferred until after the war came to a close. Waverly's first railroad, the

Cedar Falls and Minnesota Railroad was extended to Waverly in 1864. Eventually track was also laid for other branch lines and an electric interurban. By 1917 track for branch lines was absorbed by the Chicago and Great Western Railroad and the Chicago, Rock Island and Pacific Railroad. Track for the electric interurban – the Waterloo, Cedar Falls, and Northern – was laid in 1910 but usage was never as substantial as predicted.

Waverly grew in the manner typical of other Iowa county seats in the late 19th and early 20th century. Its commercial center extended along the east-west route of Bremer Avenue on both sides of the Bremer Avenue Bridge that crossed the L-shaped course of the Cedar River as it passed through the center of town. The county courthouse was located outside of the commercial area on a slight prominence at the east end of Bremer Avenue. Residential districts grew up in the four quadrants formed by the intersecting main street and river. The broad, generally flat profile of both the business district and early residential neighborhoods saw the regular occurrence of flooding resulting in the gradual replacement of most first generation frame building stock. German immigrants were among the largest ethnic group to populate Waverly during the 19th century establishing religious institutions with ethnic affiliations such as St. Paul's Lutheran Church in the northwest quadrant, St. Mary's Roman Catholic Church in southeast quadrant, and the German Methodist Church.

Bremer County and its county seat of Waverly prospered during the late 19th and early 20th century becoming a retail and professional services center for Bremer County and sections of adjacent Butler County. The county's standing as the "Dairy Spot of Iowa," gave rise to a number of dairy industries including a manufacturing plant operated by the Carnation Milk Products Company for the production of condensed milk in the 1920s. Population stood at 16,300 people in 1900 before the growth rate slowed before World War I. By 1930 population topped 17,000. Expansion of a Lutheran seminary in Waverly first located in the community in 1879 through the relocation of Wartburg College to the community in 1939 was a cultural and economic stimulus for the community. Waverly continued to add a 1,000 people per decade until 1950 when the post-War boom saw growth accelerate to more than 21,000 by 1960. During the past 50 years population has slowed somewhat topping out at 23,325 in 2000.

Historical Background for the Burbank-Richards House at 209 4th St SW:

The Burbank-Richards House at 209 4th St SW is located in the southwest quadrant of Waverly that includes additions platted by Ira Sturdevant and his son William Sturdevant. The Sturdevant family moved to the unsettled area along the Cedar River in the mid-1850s. Ira received a 40-acre federal land grant based on his military service in the War of 1812. William acquired 80 acres of adjoining land to the north of his father's 40-acre parcel. In 1857 the William Sturdevant's Addition was laid out and in 1860 the Ira Sturdevant Addition was platted. Settlement remained sparse in the additions until after the Civil War.

The Burbank-Richards House is estimated to have been constructed in 1898 according to the Bremer County Assessor's records. This date is consistent with the vernacular architectural form of the building and window designs. Property transfer records show the parcel held by the Burbank family before 1900 and passing from Jerusha Burbank, widow of Dr. Jerome Burbank, to Minnie M. Burbank on 4/20/1898 one year after Jerome died. It is not clear whether or not a house was on the parcel at the time nor what the familial relationship of Jerome and Jerusha Burbank was to Minnie.

By 1909, the property passed to Annie Richards and in later years to Maude M. Richards and her husband Edwin C. Richards. E.C. and Maude Richards were listed as residing at 209 4th St SW in the 1913 city

directory with Edwin co-owner of Richards and King, a plumbing business headquartered at 307 E. Bremer Ave. Maude died in 1932 and Edwin in 1940 with the house passing to Louise Richards in 1943. She resided here into the 1960s and died in 1969.






