6) New Business - *Postcard Advertisement* - With 3 hangars available, it was discussed, at the February meeting, about advertising to area aircraft owners. A postcard idea was one of those options. The card has 3 photos on the front, showing the airport, the bulk hangar and a brief description. The back lists the various services available. Edited items include a corrected contact phone number, the FAA airport identifier (C25) and SS (Self Service) after 24-hour fuel. The postcard will get mailed to about 100 aircraft owners in the surrounding area. One area of targeted interest is lowa Falls. Iowa Falls Airport is supposed to close their airport starting April 1st through September 1st for runway repaving. Possibly some owners might have an interest in relocating, even temporarily. The cost per card is approximately 50 cents, \$50 total. The card design and layout was performed "in house" by Jennie Waller.

FY2022 State Funded Project Application - Mike Cherry talked with Jay Pudence, McClure Engineering, about an avionics room. Jay said he will need to do some research and will respond. Last year the airport was turned down for state funding to reconstruct the taxi lanes. Mike indicated, as with other airport projects, it might take 2 or 3 times of applying to get the funding approval; ie., the Bulk Hangar Insulation Project in 2018 was applied for 3 times before approval. The application for rebuilding the taxi lanes will come before the Commission next month and then on to City Council for approval. If approved, we, the City and the Commission, should have an answer from the state within a couple of months, around Labor Day. If we should get turned down by the state, the Taxi Lane Project is eligible for federal funding, though it may have to be done as 2 separate projects.
