- 1. Motion by Main to approve Agenda with change moving item 9. 'Proposed 2024-25 board goals' to come before item 8. "Topics under study by P&P Committee", seconded by Podhajsky. Approved.
- 2. Motion by Janssen to approve September 2024 meeting minutes, seconded by Wharram. Approved.
- 3. Financials presented by Budget & Finance Committee. Motion from committee to approve financials. (no second needed) All in favor, approved.
- 4. Set budget proposal to Bremer County Library Association (BCLA): Motion by Main to propose 4% to the BCLA as a requested increase in funding from the county. Second Podhajsky. Approved. Proposals from each county library are typically averaged by the BCLA to create the final request to the Bremer County Supervisors for an increase in library funding across the county.

- 6. The following policies were presented by the Personnel & Policies Committee: Limited Access Policy – Bookmobile was removed to comply with Iowa Code. Approved. Young Patron Safety Policy – Revised. Approved Closing Policy – No Changes. Approved.
- 7. Janssen discussed the 2024-25 Board Goals:

  - #2. Anticipate trustee vacancies and implement effective trustee recruitment.
- 9. Janssen presented topics being studied by the Personnel & Policy Committee regarding director pay equity and annual review.
